Our SLIA Ramadan Iftar programme commenced on Saturday, 28<sup>th</sup> May and I am pleased to report that Alhamdulillah, the four Iftar functions were well attended and received by the membership and that the 'Hizb' programme recorded attendance at some 150+. Jazak Allahu Khayrun to all the sponsors, donors and those who worked tirelessly to ensure this very important and annual tradition's success. I am also pleased to report that Alhamdulillah our Ramadan appeal 2017 helped feed some 300+ families in Sri Lanka with parcels of dry food rations being distributed to help our Muslim brothers and sisters, allowing them to participate in Ramadan with us. This food distribution project originally started in 2014 and thanks to your donations to provide support to our sponsored villages ran for the fourth year this summer. May Almighty Allah (SWT) continue to help us in our efforts to help our Ummah.

This Ramadan saw the introduction of a new initiative 'SLIA celebrating our elders' an innovative suggestion by our respected member, Sister Zohara Farook Saleem to acknowledge and celebrate our more elderly members during Ramadan. We invited you to nominate members and to join ExCo visits and spend time with the families and help distribute 'Ramadan hampers'. Alhamdulillah twelve families were visited and hampers distributed. Alhamdulillah, SLIA presented a cheque to the Muslim Aid representative for £17,882.70 in respect of the SLIA-Muslim Aid 5K Walk for Syria Medical Emergency Appeal. A very special thank you to the ladies of the Association for this fundraising initiative and Jazak Allahu khayran to all the 'walkers', and the donors and the generous donations we received. A cheque was also presented to the Sri Lankan High Commissioner, Her Excellency Amari Wijewardene for £500 to provide assistance towards the Sri Lanka Flood relief rehabilitation projects.

The Treasurer, Fazly Wahab has been very busy and the position of our accounts is detailed in his report on page 3 for reference. I am pleased to report that the Ramadan Appeal resulted in receipts of £8K and included £1,148.98 following the SLIA Ramadan Appeal we

#### **Charity Account**

## **Building Sub-committee Report**

By the Grace of Almighty Allah we are pleased to announce that the SLIA Centre continues to be rented and the closing balance as at  $22^{nd}$  August is £48,749.59 and we have incurred expenses for planning application fees of £1,394.63.

#### Plans for this Year

**Current Status** 

I wish to inform the membership that our tenant has informed ExCo that he has been experiencing poor business performance and wishes to assign the lease to a prospective tenant. We have been liaising with our solicitors, Jumma, instructing them to act on our behalf and to review this request for lease assignment. The rent review is due on 31<sup>st</sup> August and we are currently conducting a detailed rent valuation, pre and post rear extension through a Royal Institution of Chartered Surveyor (RICS) qualified valuer. We have also formally informed the tenant of our intention to trigger the rent review notice.

In accordance with the existing lease agreement we have been in discussions with the prospective tenant regarding our intention to carry out the extension work as soon as possible. Following the rent valuation we will be deciding the new rent for the enlarged space. As long as the new tenant is in agreement with our intention to implement the rear extension and the new rent, we will be considering the lease assignment.

Over the next few weeks we shall be seeking quotes for the rear extension and Insha' Allah following this and upon completion of our negotiations with tenant we shall be in a position to provide a more comprehensive update to you in the next newsletter.

## Charity Sub-committee Post Ramadan Update 2017

#### Neeravipitty, Mullaitivu – Capacity Building Projects in Partnership with Volunteer Organisation for Social Development (VOSD)

The SLIA Charity Sub-committee is working with VOSD to capacity build Neeravipitty village on many levels from the funds that you as our membership have generously donated. An update on these initiatives follows.

But first, I would like to share my experience of the people I met there. Bold people, committed to renewing their lives despite having experienced 30 years in refugee camps after having been forcibly ejected from their homes by the LTTE's threats. The Muslim brothers and sisters and families that you are supporting in this village of Neeravipitty in Mullaitivu are among the poorest people in Sri Lanka. They are even poorer than the poorest Tamil communities in the area. They survive by activities such as collecting and selling firewood and selling cloth door-to-door. This is not what they did 30 years ago, but it is what they are doing now in order to survive and bring up their children as good Muslims. I was struck by their courage, their entrepreneurial spirit and their commitment to build a better future for their community.

It is in this context that past President, Haleem Ossman brought this village to our attention 4 years ago, and in which we continue to support the capacity building of this village.

#### **Community Building Project**

The Community Development building that we are also looking to sponsor with your donations is in the planning stages. VOSD has applied for land approval and is intending to start operational work in April. The next step here is to get a Trust document for the land and building finalised and signed by Trustees on both sides in a form that is acceptable to both parties – SLIA and VOSD. The estimated project cost is £42,000.

#### Water/Toilets Project

Over the last three years your funds have provided 30 outside toilets. Whilst we may think that there is one toilet per household, Salah and I saw situations in which a toilet was being shared by a cluster of 5 households due to lack of availability. It was a very heart-rending scenario for all of us.

The SLIA's higher level thinking generated insight for our delivery partner, VOSD, and they have since sought and received funding from the UAE's Sharjah Charity International who have provided money to supply nondrinking water tube wells to many of the houses.

VOSD representative Brother Mahroof assured me that no further toilets would be built unless such a well was within easy reach. I saw many such tube well supplies on my visit and it is clear that this is a properly funded programme that will reach many of the houses in the village. I also saw a few homes where the homeowners had taken their own initiative and installed their own duct wells. A new Government initiative has also started whereby families that can afford to pay more can have toilets installed as part of the house building programme...although this is a substantially higher cost and many wont be able to afford it.



Given this new source of tube well funding, SLIA funds will go to providing 15 drinking water taps within a small neighbourhood. VOSD had identified 3 sources of drinking water wells for this project, of which the Government had only approved one – and took a month doing that!

#### Water/Toilets Project continued...

Now here's the story that moved me most. The approved well was on land owned by Zai Abdul Cader, a slight and elderly widow with a beaming smile and deep wisdom in her eyes. Alhamdulillah, she was generous enough to donate the well on her land to her community. The 75m deep well will be used to fill a 1000 litre tank, 4 times a day and is planned to go live this month. A committee governed by the local mosque will manage the facility and the 15 families will pool and pay the joint costs for electricity, maintenance and other necessary expenses. The committee will also manage fair usage and take responsibility for making sure the solution works as best as possible for all involved.



On a lighter note, we were amazed by the spread prepared for us by VOSD – devilled squid, fried beef, chicken curry, fried fish and prawns with at least 5 other vegetable curries and rice laid out for us by Brothers Hallaj and Mahroof...most unexpected and much appreciated.

Finally, I want to thank my cousin Farah for driving us there and back from Jaffna despite her very busy schedule, and my son Salah for joining our visit and asking engineering-type questions that enabled me to understand the more technical details of the projects.

I hope this story gives you an insight into the people you are supporting and their spirit in overcoming hardship that we SLIA members have been fortunate not to face. It reminds me of my favourite line in my favourite Surah in the Holy Quran: "Which is it of the favours of your Lord, that ye deny?"

May the Almighty Allah swt make us grateful for the favours he has blessed us with, save us from such plight as the inspiring people of Neeravipitty are having to overcome, and reward us for the small but impactful contribution our community can make to help others insha' Allah.

#### SLIA Ramadan 2017 Update and Funds Appeal



Alhamdulillah, we received donations of £8,147 from our members, and this year we paid out more than the received amount to feed over 300 poor families at a cost of £9,180.53 as part of our 2017 Ramadan Appeal, made up of £4,671.85 donated to Neeravipitty and £4,508.68 to the Tsunami Village Ramadan appeals.

## The Pilgrimage through the eyes of the famous

Much has been written about Hajj and there are excellent books and websites that talk about the significance, the rituals and constraints for the pilgrims. Some of these links are shown below for reference and I shall not cover such ground as these aspects of Hajj have been amply and well documented.

This article is about some of the famous pilgrims who have performed the Hajj in the past few centuries. In the 18<sup>th</sup> and 19<sup>th</sup> century there were some Orientalists who performed the pilgrimage. Some aristocrats who converted to Islam were attracted to the simplicity of worship and the peace that they saw living among the Muslims before the advent of Western influence among the Arabs. One prominent aristocrat was **Lady Evelyn Cobbold** (1867–1963), also known as Sayyidah Zainab. She was a socialite known among Mayfair circles but was also at ease living in the Libyan desert. This Anglo-Scottish aristocrat and landowner who spent many childhood winters in North Africa, became the first Britishborn Muslim woman to perform the pilgrimage to Makkah. In 1934 she wrote a book "Pilgrimage to Mecca".

Even though aware that she was creating history, by being the first British woman on record to have made the pilgrimage, this gave way to deeper emotions as she prayed in the Haram (the Holy Sanctuary) in Makkah.

"It would require a master pen to describe that scene, poignant in its intensity of that great concourse of humanity of which I was one small unit, completely lost to their surroundings in a fervor of religious enthusiasm. Many of the pilgrims had tears streaming down their cheeks; others raised their faces to the starlit sky that had witnessed this drama so often in the past centuries. The shining eyes, the passionate appeals, the pitiful hands outstretched in prayer moved me in a way that nothing had ever done before, and I felt caught up in a strong wave of spiritual exaltation. I was one with the rest of the pilgrims in a sublime act of complete surrender to the Supreme Will, which is Islam."

She hung onto her faith until the very end:

"When I look into my journal I shall live it all again. Time cannot rob me of the memories that I treasure in my heart... the countless pilgrims who passed me with shining eyes of faith, the wonder and glory of the Haram of Makkah, the great pilgrimage through the desert and the hills to Arafat, and above all the abiding sense of joy and fulfilment that possesses the soul."

Later, in the 20<sup>th</sup> century **Muhammad Marmaduke Pickthall**, a Western writer noted for his English translation of the Quran in 1930, and **William Henry Quilliam** (Abdullah Quilliam), noted for founding England's first mosque and Islamic centre, both contributed to establishing Islam in Britain.

In recent times, **Malcolm X** (Al-Hajj Malik El-Shabazz) the famous and charismatic African-American leader of the "Nation of Islam" a group in the forefront of racial activism in the USA in the 1960's. During his pilgrimage to Mecca in 1964 he realised that Islam was a religion of unity among all nations and that both blacks and whites could co-exist in Islam by following the laws of Islam. This experience was also a factor that made him move away from the "Nation of Islam" and its divisive policies. Whilst in Mecca he wrote a letter to his loyal assistants in Harlem:

"Never have I witnessed such sincere hospitality and overwhelming spirit of true brotherhood as is practised by people of all colours and races here in this ancient Holy Land, the home of Abraham, Muhammad and all the other Prophets of the Holy Scriptures. For the past week, I have been utterly speechless and spellbound by the graciousness I see displayed all around me by people of all colours ... from blue-eyed blondes to black-skinned Africans. But we were all participating in the same ritual, displaying a spirit of unity and brotherhood that my experiences in America had led me to believe could never exist between the white and non-white."

**Mike Tyson (**Malik Abdul Aziz), the American former heavyweight champion boxer in 2003 was at his lowest, penniless, a drug addict and in jail. It was here in jail that he converted to Islam and then went to Hajj in 2010. He said:

"I'm very grateful to be a Muslim. Allah doesn't need me, I need Allah. I could never be humble. There's not a humble bone in my body. If I was humble I would never use the word humble, I strive to be humble, I want to be humble but it's a hard thing. It's a very hard thing. To be humble is to not take yourself seriously. I try to do that. I work on it. People think I'm humble but I'm not".

**Dr Martin Lings** (Abu Bakr Siraj Ad-Din) now deceased was a public-school educated Englishman who converted to Islam and spent many years as keeper of oriental manuscripts and printed books at the British Museum, and is best known as the author of "Life of Muhammad". In 1948 he performed the Hajj pilgrimage and said:

".....not only a journey in space to the centre towards which one has always turned one's face in prayers, but also a journey in time far back beyond the missions of Muhammad, Jesus and Moses ..."

The Hajj pilgrimage as those of us who are privileged by Allah's invitation to his Haram (holy sanctuary) know, that it offers many moving emotional experiences.

In the wisdom of our deen, the pilgrimage makes us realise that Islam is a universal religion and we are all his Ibadees (devotees), for He is our Creator and Fashioner, and to Him we shall all return.

Another benefit is the realisation that acting on the fifth pillar of Islam, and any other pillar, is for our benefit and not for Allah's benefit. Allah does not need our worship, for it neither adds to nor decreases His Supremacy, Majesty and Greatness. In a Hadith Qudsi Allah (SWT) says

".... O' My servants, were the first of you and the last of you, the human of you and the jinn of you to be as pious as the most pious heart of any one man of you, that would not increase My kingdom in anything....."

Also, Quran Verse (2:116)

"......Be He glorified! Nay, but whatsoever is in the heavens and the earth is His. All are subservient unto Him".


