### Subscriptions

So far this year, we have received the sum of  $\pm 2,086.00$  in membership subscriptions.

### **Charity Account**

The Charity Account funds at  $31_{st}$  December 2018, stands at £62,742.95. I am pleased to report that we remitted £3,436.31 to VOSD who undertook a project to supply School Materials for 200 children in Mullaithivu. Further, a balance of £4,993.00 is retained following the funds collected on behalf of 'Walk for Syria' and shall be issued to a reputable charity pending sign-off from Executive Committee.

### **Building Account**

This is rent received from our tenant at the Hanwell Building each month. The balance as at  $31_{st}$  December 2018 stands at £63,606.41.

### **Distress Account**

This fund is only utilised for payment of the  $\pm 250$  to the family of a bereaved member and, is subject to receipt of their annual subscriptions. This year we have issued one payment and the balance as at  $31_{st}$  December 2018 is  $\pm 2,335.00$ .

# **Building Sub-Committee Report**

### Current Status

The SLIA Building has been let out for the past 5 years (since Aug 2013), to a Muslim tenant, Hanwell Kitchen Centre, and Alhamdhulillah we have had a largely trouble-free period until recently. In the period July to Sept 2018 and then again from December 2018, we have had delays or no payment of the monthly rent and despite two face-to-face meetings with the Tenant – which had the desired effect to restart/payback rent payments – we are in the unfortunate position that the tenant is in arrears by six months.

We have now sought advice from our lawyers and have instructed the lawyers to start proceeding in the most effective way possible to ensure we recover all rents due to us and, if the case persists, for us to terminate the tenancy. We are also in touch with the local agents from the area to assess the market condition for re-letting the property, if and when the tenancy is terminated.

Finally, the Sub-Committee is also working with the architect / engineer to restart and re-assess the various building options / timescales and costs, so that we may also consider our options to develop the premises before we let the property again, to a new tenant. Planning application for the 2 storey rear extension was granted in 2017, and therefore remains an option if we are able to get a break in the tenancy to develop and then re-let, under a new tenancy agreement.

# **Charity Sub-Committee Report**

Thank you for your continued generous support and we pray that our charitable work is accepted by Allah (SWT). We continue to work with experienced local organisations that can provide detailed budgets and reporting. Below is a brief update on our projects:





SLIA agreed to transfer £3.436.31 in December 2018 to a zakat-eligible education project managed by a local charity, the Volunteer Organisation for Social Development (VOSD). Children from poor families are often held back from accessing the basic education provided by free schools in Sri Lanka due to the prohibitive costs of school materials, books and stationery, which

are not provided free. Since education of children is vital for community development and long-term poverty-relief, SLIA were happy to support VOSD in procuring a carefully costed package of school supplies for 200 poor and needy boys and girls in Grades 6 -11. Each child was provided with a school bag, shoes, exercise books, pens, pencils and other necessary supplies based on equipment lists provided by their schools. This vital package of school supplies meant that the children were able to attend school at the start of term in January 2019.



### Legacy Projects: Neeravipitty Village - School Building Initiative and Toilet/Water Project:

£22,500 (donated for this specific initiative) was allocated to fund a joint project with VOSD to build an educational and vocational training centre for returning refugees and their children, on land to be donated to VOSD. The returning refugees were primarily Muslims, but VOSD is committed to helping the poor and needy, irrespective of race or religion. Although legal documents were drafted to allow a trust to hold the land and future building for the benefit of the local community, the donation of the land to the trust is unfortunately not going ahead. VOSD has identified a possible alternative plot of land and building that the trust could purchase using the funds set aside for this project.

Alhamdulillah, the SL government has taken over from us in funding toilets and water for the area.

### Muslim Aid/Syria Project:


The 2017 Walk for Syria event raised over £20,000 to help civilians trapped in Syria's civil war, of which £17,882.70 was sent to Muslim Aid's Syria Appeal. As Muslim Aid did not provide detailed reporting on where the funds were applied, the Charity Sub-Committee would welcome suggestions for a suitable local charity working in Syria to which we can donate the remaining funds, provided it can give us reports and receipts for Charity Commission and AGM purposes.
