Secretary's Report

Assalamu alaikum wa rahmatullahi wa baraka tuhu

The beginning of the new ExCo year was marred by tragedy as our first meeting coincided with a shattering and incomprehensible terrorist attack by Sri Lankan Muslim extremists against civilians in Sri Lanka.

The suicide bombers targeted locals and foreigners on Easter Sunday, a day that was chosen to inflict maximum damage to the Christian community. Their victims were ordinary people, the majority of whom were peacefully engaged in acts of remembrance of God, or simply trying to earn a living to support their families, or relaxing in the tranquillity of a church or a hotel. Many of the dead and injured and their families came from the poorest sections of Sri Lankan society. Their daily lives were already punctuated by hardship and financial difficulty, but in a split second it all became infinitely, impossibly harder.

A significant proportion of the victims are children who, having only experienced the fragile post-civil war peace, had little comprehension of bombs and shrapnel. Many have been left severely traumatised by those seduced by a twisted interpretation of 'martyrdom'. It was jarring that one of my first official tasks as SLIA Secretary was to send a message of condolence from the SLIA to Her Excellency, Ms Manisha Gunasekera, High Commissioner of Sri Lanka for the UK; and in an effort to build inter-faith links, another to Cardinal Vincent Nichols, the Catholic Archbishop of Westminster, who invited us to visit. Members of the ExCo and their children participated in the multi-ethnic, multi-faith gathering outside the Sri Lankan High Commission on Saturday 27th April and signed the condolence book.

Many SLIA members have mentioned the deeply touching and inspirational leadership of New Zealand PM, Jacinda Ardern, following the Christchurch mosque massacres. It seems apparent from the wording of the resolution at the AGM, seeking to amend the purpose of the SLIA as stated in the SLIA constitution, that many members wish to take our Islamic Association in a direction that Insha'Allah includes building ties with other communities and giving charity to poor and needy non-Muslims as well as Muslims. Many of you have expressed a wish for the SLIA to support the non-Muslim victims of this latest terrorist attack in Sri Lanka. Our SLIA Ramadan Appeal this year therefore reflects this intention.

We hope that you will continue to support the core SLIA activities, which the ExCo works hard to deliver to our members each year. It is through your selfless hard work and generosity that SLIA events coalesce into a unique expression of Muslim Sri Lankan British identity, that may hopefully provide a sense of community, inspiration and security for the next generation.

Ramadan food distribution programme 2019

- 1. **Hambantota Suchi Village:** The feeding of 150 families with dry food rations at RS 6,395 per family with a view to Insha Allah help our Muslim brothers and sisters to be in a position to participate in Ramadan along with us all. *This project with associated packaging costs is estimated at £4,309 at an exchange rate of RS 225.*
- 2. **Hambantota Tsunami Village**: The feeding of 170 families with dry rations at RS 6,395 per family and also provision of Khanji for 10 days estimated at RS 7,500 per day. *This project with associated packaging and transport costs is estimated at £5,280 at an exchange rate of RS 225.*
- 3. **Mullaithivu Hijrapuram & Neeravipitty Village:** The feeding of 200 families with dry rations at RS 7,410 per family. This project with associated packaging, printing and distribution costs is estimated at £6,697 at an *exchange rate of RS 225*.

NOTICE OF SPECIAL GENERAL MEETING AT 9.30PM (AFTER IFTAR AND BEFORE HIZB) ON SATURDAY 25 MAY 2019 AT CLAREMONT SCHOOL. KENTON, HARROW HA3 0UH

Dear Brothers and Sisters in Islam, Assalamu Alaikum.

At the AGM of the Sri Lanka Islamic [UK] Association (hereafter referred to as 'SLIA'), held on 28 March 2004, the membership passed a resolution to amend Article 11 of the constitution of the SLIA to reduce the Executive Committee from nine office bearers and five committee members to six office bearers and five committee members.

At a Special General Meeting on 19 June 2004 the membership passed a resolution to amend Article 12 of the constitution of the SLIA to reduce the quorum of the Executive Committee from nine members to seven members. This was due to the difficulty in establishing a quorum of nine members at every Executive Committee meeting, and in order to not delay important and time-constrained decisions.

The current Executive Committee (ExCo) was informed by the Charity Commission that both the March and June 2004 resolutions to amend the constitution, and any subsequent resolutions to reduce the quorum to seven in the constitution, do not appear to have been filed with the Charity Commission and have not received Charity Commission approval. The SLIA constitution forwarded to us by the Charity Commission shows an Executive Committee of nine office bearers and five committee members, and a quorum of nine.

It is a legal requirement that a registered Charity operates according to its constitution and any resolutions to amend the Charity's constitution, together with the amended constitution, must be lodged with and approved by the Charity Commission. A failure to do so potentially exposes past and present SLIA trustees and the SLIA to a risk of sanctions. The ExCo has not been able to locate the minutes of the 2004 Meetings or the two signed 2004 resolutions to amend the constitution in order to forward to the Charity Commission.

In addition, at the AGM of the SLIA held on 7 April 2019, the members voted to pass a resolution to amend Article 2 - the Objects clause of the constitution. The Charity Commission has now given its consent to the amendment but has slightly altered the wording of the resolution passed at the AGM. A new resolution with this wording will therefore need to be passed at a General Meeting.

It was resolved at ExCo meetings on 21 April and 3 May 2019, to hold a **Special General Meeting (SGM) on 25th May 2019 at 9.30pm at Claremont School, Kenton, Harrow HA3 0UH,** in accordance with Article 10 of the SLIA constitution, to:

(1) propose a resolution ratifying the two previous resolutions passed in March and June 2004 to amend the SLIA constitution.; and

(2) to vote on a resolution to amend the Objects of the constitution in line with the wording suggested by the Charity Commission.

Formalities on Voting

The voting rights of members are determined by Article 4 - Membership, within the SLIA (UK) constitution as amended in March 2006.

- 1. Ordinary Members have full voting rights but must be resident in the UK and over 18 years of age. There are 6 categories of Ordinary membership:
- a) Single Membership one vote per member
- b) Family Membership voting is restricted to one vote for each of the husband and wife. (Family is defined as husband, wife & children under 18 years of age)
- c) Life Membership voting is restricted to a single vote
- d) Student Membership voting is restricted to a single vote (Student members are over 18 years of age and in full time education)
- e) Retired Membership one vote per member
- f) Widow/Widower Membership one vote per member
- Associate Members do NOT qualify for ordinary membership and are NOT Eligible to vote but can attend meetings. There are 2 categories of Associate Membership: (a) Family Membership and (b) Single Membership.
- 3. Voting will be by a show of hands for or against passing each resolution.
- 4. Under Article 18 section (b) of the SLIA constitution –an amendment of the constitution by a General Meeting is determined by a two-thirds majority of members entitled to vote and present at such meeting. Resolution of Sri Lanka Islamic (UK) Association (Charity No.: 1098114)

That the membership ratifies the following two resolutions:

- The resolution passed at the 28th March 2004 AGM to amend Article 11 of the constitution of the Sri Lanka Islamic [UK] Association to reduce the Executive Committee from nine office bearers and five committee members to six office bearers and five committee members
- 2) The resolution passed at the Special General Meeting on 19th June 2004 to reduce the quorum of the Executive Committee of the Sri Lanka Islamic [UK] Association from nine to seven executive committee members.

Resolution of Sri Lanka Islamic (UK) Association (Charity No.: 1098114)

That Article 2 - the Objects – be amended as follows:

By adding subsection (d) namely:

(d) To prevent or relieve poverty of suffering communities worldwide by facilitating humanitarian activities, and supporting welfare projects for the social upliftment of poor communities in Sri Lanka.
